### **GUIDE FOR PAYMENT OF NOMINATION FEES**

#### **1.0 LEGAL REQUIREMENT**

Section 11(3) of Parliamentary Elections Act, 2005 (as amended) provides that the nomination paper shall be accompanied by a nomination fee of one hundred and fifty currency points, equivalent to shs. 3,000,000/= (Three million shillings only).

#### **2.0 PAYMENT PROCEDURE**

Note: Aspiring candidates shall pay nomination fees to UGANDA REVENUE AUTHORITY (URA) as follows:

##### **(a) Payment Registration Number (PRN)**

- (i) Go to URA Website [www.ura.go.ug](http://www.ura.go.ug)
- (ii) Register and obtain a Payment Registration Number (PRN)

##### **(b) Payment through Banks**

Aspiring candidates may make the payment through any bank that collects revenue on behalf of URA as follows:

- (i) Present the payment Registration Number (PRN) that shall facilitate the payment to the URA account.
- (ii) Pay 3,000,000/= plus bank charges in the bank.
- (iii) The bank will provide a BANK RECEIPT in acknowledgement of payment.

#### **3. CONFIRMING PAYMENT OF NOMINATION FEE**

- (i) The aspiring candidate shall present the "BANK RECEIPT" obtained from the bank to Electoral Commission on or before nomination day.
- (ii) The Commission shall verify the payment with URA.
- (iii) The Electoral Commission shall then issue a GENERAL RECEIPT to the intending candidate confirming payment of nomination fee.

#### **4. PRESENTATION OF THE GENERAL RECEIPT TO THE RETURNING OFFICER**

On nomination day the intending candidate shall present the GENERAL RECEIPT to the Returning Officer with other nomination documents, confirming payment of the nomination fee.
