Press Statement on the Update for Conduct of Women Councils and Committees Elections and Other Electoral-related Activities

1.0 Introduction

Our esteemed partners, members of the press, it is my privilege and pleasure to welcome you to our press briefing.

Today, the Commission would like to update you and the general public concerning the programme for Women Councils and Committees Elections and other electoral-related activities, as follows:

2.0 Finalization of the Countrywide Verification of Administrative Units (Villages and Parishes)

In preparation for the conduct of Women Councils and Committees Elections 2022 and Administrative Units (LC 1 & LC 2) Elections 2023, the Electoral Commission conducted a countrywide exercise to compare, verify, harmonise and confirm all administrative units (villages/cells, parishes/wards and sub-counties).

The exercise was conducted from 16th March to 27th March 2022, and the Electoral Commission, in conjunction with the Ministry of Local Government, have finalized the processing of the returns.

The purpose of the exercise was to update the list of Villages, Parishes and Sub-counties in the country upon which the Women Councils and Committees Elections of 2022 and the Administrative Units (LC 1 & LC 2) Elections of 2023, will be based, in accordance with Section 7 of the Local Government Act, Cap 243.

Accordingly, the number of Administrative Units in Uganda for purposes of conducting the Women Councils and Committees Elections, 2022 will be as follows:

The Commission will issue the list to political parties and organizations to enable them prepare for presenting of candidates during the conduct of Women Councils and Committees Elections to be held this year (2022) and Administrative Units (LC1 & LC2) Elections which will be held in 2023.

The Commission will also publish the harmonized and updated list of Administrative Units onto the website for public access.

3.0 Programme for the Conduct of Women Councils and Committees Elections

The current Women Councils and Committees were elected during the period June – August 2018, and the Executive Committee of the National Women's Council was constituted on 23rd - 24 August 2018.

According to the National Women's Council Act, the terms of office of the said Councils and Committees is four (4) years, implying their term will elapse in August 2022.

Accordingly, the Electoral Commission did earlier issue the programme for the elections of Women Councils and Committees Elections from the Village to the National level as follows:

The Commission wishes to highlight the following key activities that will be undertaken at the village level, which forms the basis for the conduct of the elections in a progressive manner up to the national level.

4.0 Compilation of Register for Election of Village Women Executive Committees 10th – 13th June 2022

In preparation for the Women Councils and Committees Elections, the Electoral Commission will compile a register of willing female residents in each village throughout Uganda from Friday 10th June to Monday 13th June 2022.

The purpose of this registration exercise is to enable all willing female residents aged 18 years and above, to register in order to participate in the above elections within their respective villages.

The registration will be conducted from 7:00am until 6:00pm on each of the appointed dates, including weekends.

All stakeholders are urged to note the following:

- a) Eligible and willing female residents aged 18 years and above shall turn up in person at the registration centre within the village of residence to register;
- b) The registration exercise shall be for the sole purpose of electing the Village Women's Executive Committee;
- c) The village women residents shall be registered in a customized Register Book provided by the Electoral Commission;
- d) For one to register in the Village Women Residents Register, she must fulfill the following requirements;
 - i. Must be a citizen of Uganda, who is ordinarily resident in the Village of registration;
 - ii. Must be eighteen (18) years of age and above at the time of registration;

iii. Must be willing to be a member of the Village Council;

- e) A person appearing for registration shall be required to provide the following particulars to the Village Election Official:
 - i. Names;
 - ii. National Identity Number or Application ID Number,
 - iii. Age,
 - iv. Gender, and,
 - v. Village of Residence.

e) The registration exercise shall be free of charge.

The Commission has further appointed Monday 13th June 2022, as the cut-off date for registration of female village residents. Hence, the registration of female residents in each village throughout Uganda will not be conducted after this date.

5.0Display of the Village Female Residents Register, 23rd - 24th June 2022

The display of the Register will be from $23^{rd} - 24^{th}$ June 2022 in all the villages across the country.

The display of the above Registers shall begin at 8:00am and end at 6:00pm at the designated public/open place in the respective village.

During the display, the voters are urged to turn up in large numbers and check for the correctness of their particulars, such as names, National ID Number or Application ID Number, age, gender and village of residence.

Residents are further urged to report to the Village Election Official the following categories of persons for removal from the Registers:

- a) The under-aged, and,
- b) Those who do not reside in the village.

6.0 Composition of the Village Women's Committee

The Village Women's Committee shall consist of the following five (5) positions:

- a) Chairperson;
- b) Vice Chairperson;
- c) Secretary;
- d) Publicity Secretary; and
- e) Secretary for Finance.

7.0Nomination of Candidates for the Women Councils Elections at the Village Level, 27th June to 1st July 2022

The nomination of candidates for Village Women Executive Committees will be conducted from <u>27th June to 1st July 2022</u> at the respective Sub County/City Division Headquarters'.

- a) An aspiring candidate for any office on the Women's Committee shall be a female ordinarily resident in the village, aged eighteen (18) years of age or above and a citizen of Uganda.
- b) An aspiring candidate shall be registered on the Village Women's Council Register.
- c) No academic qualifications shall be required. Furthermore, no nomination fee shall be required.
- d) Nomination of candidates may be made by a political party/organization sponsoring a candidate or by a candidate standing for elections as an independent candidate without being sponsored by a political party or political organization.
- e) The conduct of Women Councils/Committees Elections are progressive in nature starting at Village and ending at National Level.
- f) This means that for one to be elected at National Level, she should have been successfully elected right from Village level.

Please note that no one can join the subsequent electoral processes if she did not participate at the Village Level.

8.0 Resignation by Public Servants

Section 7A of the National Women's Act [Cap 318] provides that; "Under the multiparty political system, nomination of candidates may be made by a [political organisation or a political party sponsoring a candidate..."

However, the Political Parties and Organisation Act [18 of 2005] prohibits public officers among others from being members of a Political Party or standing for elections under sponsorship of a political party or organisation.

Section 4(4) of the Parliamentary Elections Act [Cap 17 of 2005] and Section 116(5) of the Local Governments Act, Cap 243 also **prohibit public servants among others from seeking elective offices. For those who wish to, they shall have to resign.**

So all public Officers who wish to participate in Women Councils and Committees Elections shall be expected to resign before seeking for nomination as candidates.

9.0 Conduct of Campaigns and Polling

The candidates' campaigns for election of the Village Women Committee will be conducted from 4^{th} to 6^{th} July 2022.

The Commission has appointed <u>Thursday 7th July 2022</u> as polling day for election of the five (5) members of Village Women Committee;

The election of members of the Village Women Committee shall be by the electorate lining up behind the nominated candidates, their representatives, portraits or symbols.

Voting shall take place in a public/open place within the village, starting at 9:00am.

10.0 Observance of Standard Operating Procedures

All persons participating in the elections shall be required to comply with guidelines issued by the Electoral Commission in accordance with the Government of Uganda and Ministry of Health measures against the spread of COVID-19.

This includes observing social distancing, hand washing, and wearing of masks.

11.0 Conclusion of Parliamentary and Local Government Councils Elections in Omoro County Constituency, Omoro District

The Electoral Commission conducted and successfully concluded the by-election for Member of Parliament for Omoro County, District Woman Councillor for Lakwaya/Lalogi Electoral Area on Thursday 26th May 2022.

Please note that Oryema Terence (National Resistance Movement) had been declared elected unopposed at the closure of nominations on 13th May 2022, as Male Councillor for Older Persons representing Acet Town Council.

The Electoral Commission has declared and published in the Gazette the winning candidates for the three elective positions:

The Commission salutes the people of Omoro County on the exercise of their constitutional rights by participating in the by-elections and in a peaceful manner.

The Commission has noted statements in the media, attributed to some of the stakeholders who participated in the by-elections, alleging that the electoral exercise was not fairly conducted.

The Commission recognizes the right of the concerned stakeholders to disagree with the result of the said by-elections. We, wish to state that the by-elections were conducted in accordance with the Law and the guidelines for the exercise.

Furthermore, the Commission established a Complaints Desk which received and addressed any matters of concern that were raised and brought to our attention during polling.

Concerning the matter of low voter turn-up, the Commission notes that this is a common phenomenon in previous by-elections, as illustrated in the table below:

May their faithful witness continue to inspire us in our faith and service to God and to our country.
