The method of payment will be **by Bank in-slip obtained from cashiers office and Deposited in Diamond Trust Bank Jinja Road branch**. The document will be **delivered by hand**. No liability will be accepted for loss or late delivery.
6. Bids must be delivered to the address below at 8(c) at or before **11.00am 28th February, 2025**. All bids must be accompanied by a bid security of **UG SHS: 36,000,000**. Bid securities or bid securing declarations must be valid until **12th August, 2025**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11.15am 28th February, 2025**.
